## AUCTION NOTICE FOR DISPOSAL OF USED LUBE OIL/ WASTE OIL

On behalf of Director AIIMS, Rishikesh, are invited best binding bids for the DISPOSAL OF USED LUBE OIL kept at Sub-Stations-1 & 2.

1. SCOPE: DISPOSAL OF USED LUBE OIL/ WASTE OIL KEPT AT Substation 1 & 2.
2. Completion time: 7 days from the date of issue of Sale Order.
3. Bid due date and time: **13/01/2020**, at 14:00 Hrs.
4. Bid opening date and time: 13/01/2020, at 15:00 Hrs.
6. EMD : **Rs.5000/.**

## Terms and Conditions:-

1. The Earnest money can be deposited in form of Demand Draft or Pay order or Banker`s Cheque or Deposit at call Receipt towards cost of EMD Rs.**5,000.00/-** in favour of Director, AIIMS, Rishikesh. The EMD shall be enclosed with tender documents. The EMD for unsuccessful bidders shall be returned after opening of bids. The tenders without Earnest Money Deposit will be summarily rejected.
2. After inspection of items bidder should quote a price or an amount which he is ready to pay for the scrap offered for sale in a sealed bid.
3. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his behalf. A copy of such authority should be enclosed along with the bid.
4. Bid forms are not transferable.
5. The EMD of unsuccessful bidder will be refunded.
6. Bidder(s) can inspect the articles/items between 10.00 a.m. to 3.00 p.m. in the above mentioned address from 04/01/2020 to 12/01/2020 and on 13/01/2020 upto 11.30 a.m. on working days only. In regard to the conditions, quality etc. of the articles/items and satisfy themselves before submitting their offer by the date and time specified.
7. Any tax is livable shall be paid by the successful bidder.
8. All articles/items will be sold on "AS IS WHERE IS BASIS" (Both Lot wise and Item wise) will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quality of the articles/items proposed to be auctioned.
9. The successful bidder will be required to make full payment of bid by way of Demand Draft/Banker`s/ cash receipt of AIIMS Rishikesh after the finalization of the bid.
10. The successful bidder will have to lift the articles/items in his own cost, risk and arrangement within 7 days after depositing the full amount of payment of the bid otherwise the EMD will be confiscated.
11. The successful bidder will not be entitled to resell any of the articles/items while they are still kept within the premises of this Hospital and no delivery would be effected by this Office to any person or person(s) other than the bidder whose name/names are mentioned in the Order.
12. The condemned items/articles will be sold in one lot. The bidders shall quote the rate for one lot ie, after totaling the lot wise and item wise list of the articles enclosed along with this tender document.
13. The rate quoted will be higher than the reserve price fixed.
14. Sealed Envelopes should be super scribed as "Quotations for DISPOSAL OF USED LUBE OIL/ WASTE OIL KEPT AT Substation 1 & 2. Addressed to the Executive engineer and drop in the tender box on or before 13/01/2020 by 2.00 p.m. This Office shall not be responsible for any delay.

15. Bidder should enclose inside the sealed cover containing the tender, the following documents:
- (a) EMD Rs.5000.00/.
  - (b) The Special as well as General Terms and Conditions of bid documents, both duly signed by the bidder.
  - (c) Schedule of Rate(s) duly filled in and signed by the tenderer. (As placed in Annexure-A)
  - (d) **Attested copy of proof (Valid certificate) of having registered with MOEF/ CPCB as Recyclers/ Re-processors having Environmentally Sound Management Facilities.**
16. No bid shall be accepted after the due date and time. If the due date happens to be a holiday the bid due date will be next working day at the same time notified as above.
17. The auction shall be subject to the Indian laws and jurisdiction of the Courts located in Rishikesh.
18. The undersigned reserves the right to postpone the date of opening or accept or reject any or all the bids without assigning any reason at any stage.
19. The intending bidders may see bid documents and Specifications in the office of Superintending Engineer, AIIMS Rishikesh Engineering Unit, AIIMS, Virbhadr Marg, Rishikesh. No bid shall be entertained after the stipulated date and time.
20. The intending bidder must read the terms and conditions carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the required documents.
21. The bidder should submit self-authenticated copies of registration and document justifying their bidding capacity, copy of PAN card and GST Registration, if any, along with bid documents.
22. The competent authority on behalf of the Director, AIIMS, does not bind itself to accept the highest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
23. The competent authority on behalf of Director, AIIMS, reserves to himself the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.

24. Breach of Terms and Conditions: In Case of breach of any terms and conditions as mentioned above, the Competent Authority of AIIMS Rishikesh, will have the right to reject the bid at any stage
