Subject: Offer of appointment to the post of Nursing Officer in All India Institute of Medical Sciences (AIIMS), Rishikesh, Uttarakhand on the basis of result of Exam conducted on 23rd January 2020 and Skill Test on 25th - 26th Feb 2020 and 29th - 31st May 2020.

I am directed to say that on the basis of the result of the subject exam, you have been selected for the post of Nursing Officer in All India Institute of Medical Sciences (AIIMS), Rishikesh, Uttarakhand and are hereby offered an appointment to the aforesaid post on temporary basis in Pay Level-7 of Pay Matrix with usual allowances at the rates admissible and subject to the conditions laid down in the rules, regulations and orders governing the grant of such allowances in force from time to time at the Institute.

2. Your appointment to the post shall be governed by AIIMS Act, 1956 and Rules and Regulations made thereunder. The offer of appointment to the aforesaid post shall be subject to the following terms and conditions: -

(i) Your appointment will be purely on a temporary basis and until further orders.

(ii) Your appointment may be terminated at any time by one month's notice from either side namely the appointee or the appointing authority without assigning any reason, in accordance with Central Civil Services (Temporary Service) Rules, 1965. The Appointing Authority, however, reserves the right of terminating your services forthwith or before the expiry of the stipulated period of notice by making payment to you of a sum equivalent to the pay and allowances for the period of notice or the un-expired portion thereof.

(iii) The appointment is provisional and subject to, verification of character and antecedents from the concerned authorities as per procedure laid and your medical fitness. Furnishing of false information or suppression of any factual information in the attestation form would lead to disqualification and render the candidate unfit for employment under AIIMS, Rishikesh with resultant dismissal from service and criminal/civil/legal action, as per provisions of Indian Penal Code (IPC) etc. as deemed fit.

(iv) You will have to give an undertaking at the time of joining that if anything adverse comes out in the character and antecedent's verification or in the medical examination or the educational qualification and experience claimed to have been possessed by you as on date prescribed in the notice of exam, that would make you ineligible for appointment in the first instance, you will be liable to be discharged from service forthwith without any further notice.

(v) You will be on probation for two years, which may be extended at the discretion of the Competent Authority but the total period of extension of probation shall not, except where it is necessary by reason(s) of any departmental or legal proceedings pending against you, exceed two years. During the period of probation, you may be required to undergo such training/courses and to pass such tests as AIIMS, Rishikesh may prescribe from time to time. The probation period shall be deemed to have been extended until you receive a letter of confirmation with respect to the satisfactory completion of the initial or subsequently extended period(s) of probation.

- (vi) During the period of probation, you will be liable to be discharged from service at any time without any notice, if
- (a) On the basis of your performance or conduct you are considered unsuitable for further retention in service, or
- (b) If you are otherwise found ineligible or unsuitable for being retained in the service.
- (vii) You will be covered under the New Pension Scheme notified by the Ministry of Finance No.5/7/2003-ECB&PR dated 22.12.2003 and as amended from time to time.
- (viii) You will not be entitled to any travelling allowance for joining the appointment.
3. If you are already in service in Central Government/state Government/PSU/Autonomous Body /Bank /Corporation etc. your appointment shall be subject to vigilance clearance and relieving by the present employer.
4. The appointment will further be subject to taking an oath of allegiance/faithfulness to the Constitution of India or making solemn affirmation to that effect and oath of secrecy in the prescribed form.
5. In accordance with orders in force in regard to recruitment to service under AIIMS, Rishikesh, no person who has entered into or contracted a marriage with any person having a spouse living or who having a spouse living has entered into or contracted marriage with any person, is eligible for appointment under AIIMS, Rishikesh, provided, the Competent Authority may, if it is satisfied that there are special reason(s) for doing so, exempt any person from the operation of this rule. This offer of appointment is therefore, conditional upon satisfying the requirements mentioned above and also furnishing to this Institute a declaration to that effect in the prescribed proforma at the time of joining. If, however, you desire to be exempted from the operation of the rule for any special reason(s), you should make a representation in this behalf immediately. This offer of appointment should, in that case, be treated as cancelled and a future communication will be sent to you in due course, if upon a consideration of your representation, it is decided to offer you the appointment.
6. If you claim to belong to a Scheduled Caste, Scheduled Tribe or Other Backward Class or a person with disability, you will have to produce a certificate issued in the prescribed format by the Competent Authority. It may be noted that your appointment shall be provisional and be subject to verification of the relevant certificate through proper channels. If the verification reveals that your claim with regard to you belonging to SC/ST/Other Backward Classes/PwD or not belonging to creamy layer is false, your services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false certificate.
7. You shall intimate immediately the change, if any, in your religion after appointment to the appointing/administrative authority concerned.
8. In accordance with the relevant rules and regulations in force with regard to recruitment to the services under AIIMS, Rishikesh, if any declaration or information furnished by you proves to be false or if you are found to have willfully suppressed any material information, you shall be liable to be removed from service and to any such other action as the Competent Authority may deem fit.

9. As per the policy in place, you are required to give an undertaking at the time of joining that you will work with AIIMS, Rishikesh for a minimum period of two years against your appointment. Non completion of the stipulated term due to any reason whatsoever, will render you liable for payment of Rs. 2,00,000/- (Rupees Two lakhs) as liquidated damages, which may, at the discretion of the Competent Authority on a case to case basis, be waived off (either in full or in part).


10. Other terms and conditions will be governed by the relevant rules, regulations and orders in force from time to time at AIIMS, Rishikesh.

11. At the time of joining, you are required to furnish the following **original certificates** along with a self-attested copy there of:

- (i) 10th/Matriculation Certificate as a Proof of Name, Father's Name, Mother's Name, Age (10th/ Matriculation Certificate).
- (ii) Certificate of other Educational Qualifications, Mark Sheets, including experience, if any.
- (iii) Certificate of caste (for SC/ST/OBC category candidates)/PwD issued by the designated authority.
- (iv) Relieving order from present employer (if applicable).

12. If you accept the offer on the above terms and conditions, you should report at office of the Senior Administrative Officer, Nursing Administration, AIIMS, Rishikesh, Uttarakhand-249203 along with the above mentioned documents within 30 days from the date of issuance of this offer. Failure to join the above mentioned post or non-receipt of any communication on the subject, within the stipulated time, would automatically result in lapse of this offer of appointment with a presumption that you are not interested in joining the above mentioned post and your candidature will be processed for cancellation without any further notice.
