- Eligibility of each candidate who has applied for above said post has been intimated through email to their email ID as mentioned in application form.
- Candidates who are Provisionally Eligible (intimated through email) are hereby informed that the date examination has been rescheduled from 13th May, 2024 (Monday) TO 27th May, 2024 (Monday) due to administrative reason.
- <u>Provisionally eligible candidates have to report (IN-PERSON) on 27th May, 2024 at 9:30 AM for Eligibility & Original Document Verification followed by examination at <u>Examination Section of AIIMS Rishikesh</u> with below mentioned original documents. Candidate(s) who fails to report before 9:30 AM will not be allowed to appear in examination.</u>
- All candidates who are declared <u>Not- Eligible</u> (intimated through email) are hereby also informed that, if they have any objection / clarification or representation regarding their eligibility, they may report personally along with all supporting documents (in original and a self-attested copy of these documents) in favor of their candidature on <u>27th May 2024</u> (<u>Monday</u>) at 9:30 <u>AM</u> in <u>Recruitment Cell of this Institute</u>. After re-scrutiny, if they are found eligible, they will be allowed to appear in examination on same day. No further representation after this date will be entertained.

Interview will be held on next day i.e. on 28th May, 2024 (Tuesday). Candidates are required to report for Interview at 9:30 AM in Recruitment Cell of AIIMS Rishikesh.

 - i. Application fee proof.
 - ii. Aadhar Card
 - iii. A valid Identity proof i.e. passport, voter ID card, etc. (issued by government authority)
 - iv. Age proof (10th Certificate/ Birth Certificate).
 - v. Residence proof (issued by government authority).
 - vi. Qualification proof (Degrees & Marksheets).
 - vii. NOC document from current employer (if any).
 - viii. Reserve category document (if any).
 - ix. Experience certificate.
 - x. Any other relevant document to support your candidature.
- In case any candidate(s) fail to show the requisite original documents at the time of original document verification, they will not be allowed to appear in the examination/interview.
- Decision of Original document verification committee regarding eligibility of candidate shall be FINAL and no further communication will be entertained in this regard.
