#### Subject: Walk in Interview for the post of Junior / Senior residents at the AIIMS, Rishikesh

A walk in interview for appointment for vacant posts of Junior Residents / Senior Residents on ad-hoc and emergent basis for a period of 89 days extendable further subject to satisfactory service, till the recruitment of Senior / Junior Residents on regular basis, will be held at AIIMS Rishikesh on the specified dates.

#### I. Essential Qualification:

#### A. For Senior Residents (Pay Scale: Rs.15600-39100 + Grade Pay 6600 + NPA).

- (i) A graduate medical degree (M.B.B.S) or equivalent degree recognized by MCI.
- (ii) A postgraduate medical degree Viz. MD/MS/ DNB or Equivalent in the respective discipline from recognized University/Institute.
- (iii) To be eligible for selection for these posts, the candidate should have passed the qualifying examination by the 17<sup>th</sup> November, 2015 and result declared to this effect on or before by this date.

  The tenure of qualifying degree should also be finished latest by this date (17<sup>th</sup> November, 2015).
- (iv) Candidates who have already completed / done three years of Senior Residency will not considered.

#### B. For Junior Residents (Non Academic, Pay Scale: Rs.15600-39100 + Grade Pay 5400 + NPA)

- (i) The candidates should have passed MBBS (including completion of Internship) or equivalent degree recognized by MCI by the **16**<sup>th</sup> **November**, **2015** and result declared to this effect on or before by this date.
- (ii) Only those candidates who have passed MBBS (including Internship) not earlier than 3 years before as on the date of interview (Applicant passed before **16**<sup>th</sup> **November**, **2012** Not eligible).
- (iii) Candidates who have already completed / done three years of Junior Residency will not eligible.

# II. Upper Age Limit (17th December, 2015 for Junior Resident & 18th December, 2015 for Senior Resident): Senior Residents: 33 years, Junior Residents: 30 years.

- (i) Relaxable for SC/ST candidate up to a maximum period of 05 years, and in the case of OBC candidates up to a maximum period of 03 years.
- (ii) In the case of Orthopaedic Physical Handicapped (OPH) / Person with disabilities (PWD) candidates, relaxable upto maximum period of 05 years for General Category, 08 years for OBC category and 10 years for SC/ST category candidates.
- (iii) Reservation for SC/ST/OBC/OPH/PWD shall be applicable as per Govt. of India rules.

- OBC Candidates will attach certificate from the prescribed authority for Central Government posts along with certificate that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than one year of last date of application i.e. should not be issued before 17.12.2014.
- For SC/ST Candidates Certificate should be issued by Tehsildar or above rank officer in standard format of Central Government.
- OPH/PWD Candidates The disability certificate should be signed by duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent. The constitution of the Medical Board will be one consultant each from disciplines of Orthopaedics, Physical Medicine & Rehabilitation and Surgery.
