1. Applicants are strictly advised to apply with this heading only.
2. The candidates called for interview will be intimated **by mail only**. The decision of selection committee at AIIMS Rishikesh will be considered final in this regard.
3. No travelling or other allowances will be paid to candidate for interview/joining for the post.
4. Appointment is purely temporary on **CONTRACT BASIS** for a period of 12 months from the date of commencement of the contract and can be terminated by giving one months notice from either side.
5. Work and conduct will be reviewed time to time and if not found satisfactory/suitable, shall be terminated immediately without any notice.
6. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in institute OR for continued contractual appointment which may be renewed or terminated as per policy/rule/need of Institute.
7. Experience as asked for, should have been gained after acquiring minimum essential qualification.
8. Qualification, experience, other terms and conditions may be relaxed/ altered at the discretion of the Nodal Officer.
9. No other allowance/ facilities other than consolidated salary shall be admissible.
10. The selected candidates shall be employee of Drug Treatment Centre, AIIMS Rishikesh. The administrative part shall be looked after by the Nodal officer of DTC at AIIMS Rishikesh and these posts are funded by Ministry of Health and Family Welfare (MoHFW), Government of India.
