19. Tender Currencies:

- b. For imported goods, if supplied directly from abroad, prices shall be quoted in any freely convertible currency say US Dollar, Euro, GBP or Yen. 22. Excise Duty:

- c. Subject to sub clauses (i) & (ii) above, any change in excise duty upward/downward as a result of any statutory variation in excise duty taking place within contract terms shall be allowed to the extent of actual quantum of excise duty paid by the supplier. In case of downward revision in excise duty, the actual quantum of reduction of excise duty shall be reimbursed to the AIIMS Rishikesh by the supplier. All such adjustments shall include all reliefs, exemptions, rebates, concession etc. if any obtained by the supplier.
- 23. **Sales Tax**: If a bidder asks for sales tax/CST / VAT/CENVAT, Service Tax and Works Contract Tax to be paid extra, the rate and nature of sales tax applicable should be shown separately. The CST / VAT/CENVAT, Service Tax and Works Contract Tax will be paid as per the rate at which it is liable to be assessed or has actually been assessed provided the transaction

of sale is legally liable to sales tax/ CST / VAT/CENVAT, Service Tax and Works Contract Tax and is payable as per the terms of the contract.

- 24. **Octroi Duty and Local Duties & Taxes**:- Normally, goods to be supplied to Government departments against Government contracts are exempted from levy of town duty, Octroi duty, terminal tax and other levies of local bodies. - 25. **Customs Duty**: In respect of imported goods offered from abroad, the bidder shall specify the rate as well as the total amount of customs duty payable with Custom Duty Exemption Certificate, if applicable, on the quoted goods in the Financial Bid. The bidder shall also indicate the corresponding Indian Customs Tariff Number applicable for the goods.
 - a. For transportation of imported goods offered from abroad, relevant instructions as incorporated shall be followed.

 - b) On Acceptance: 25 % payment would be made after satisfactory installation, commissioning, demonstration and training, if required on issuance of Inspection certificate by the AIIMS, Rishikesh.
- 29. **Guarantee / Warrantee Period**: The Tenderers must quote for 5 years comprehensive warranty (Including all Spares, Accessories software application, if any and Labour) from the date of completion of the satisfactory installation. The warranty charges shall not be quoted separately otherwise the offer shall be summarily rejected. 31. **Applicable Law:**

The contract shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings / processing.

Any disputes are subject to exclusive jurisdiction of Competent Court and Forum in Rishikesh/Dehradun, Uttarakhand India only.

Except as otherwise provided under this Contract for immediate termination of the Contract, in the event of a disputes which may be arising out of the execution of the tender contract, the matter will be referred to the Deputy Director (Administration). Appeal against the decision of the DDA will lie to the Director, AIIMS Rishikesh and his decision shall be final and binding upon both the parties.

 - b) Video input Composite, S-video & VGA
 - c) All the necessary cables should be supplied
 - d) Latest genuine software with life-time license should be supplied
- 35. Anorectal manometery minimum 4 channels should be able to perform resting, squeeze, cough, push, RAIR and sensation test and anal rest or squeeze profile. Three-dimensional vector volume plot should be obtained. Should use air-charged catheters.
- 36. Pelvic floor rehabilitation system (wireless) should be able to perform the study on EMG (with surface, needle electrodes and vaginal, rectal probes), Pressure and Flow or on any combination of two signals.

Feedback animation& games (pediatric) should be available. System should also able to perform biofeedback with normal uroflowmetery in children. The biofeedback software should be pre-loaded with internationally recognized standardized protocols and should have ability to tailor currents and treatment templates.
