Report of the Store Purchase Committee

The Tender Opening Committee opened the tender for Basic Nursing Care Mannequins for Department of Nursing against Tender Enquiry No. 24/Nursing/135(II)/2016-Rish(Admn) in front of participating bidders on 28/09/2016 and found that 06 tenders received from following firms.:-

After administrative evaluation of all the tenders received, it was found that 05 firms fulfil eligibility criteria for qualification and thus declared qualified for further technical evaluation. M/S Soumya Educational Systems, Bhavnagar, Gujarat did not meet the criteria due to less turnover and non submission of corrigendum with the technical bid.

The qualified bids were then sent to the department for technical evaluation. The committee submitted its report which is attached in the file. As per the report the below firms are disqualified because of the reasons mentioned against them:

S/No	Firm Name	Reason of Disqualification
1	M/S Hospimedica International Ltd., Delhi	Disqualified because the firm does not mention about: 1. Insertion and suctioning of oropharyngeal and nasopharyngeal airways. 2. Insertions, secure and care of endotracheal tubes 3. Manually generated carotid pulse. 4. Female Genitalia capable of vaginal douching. 5. Enema procedures may be performed using fluid or realistic return.
2	M/S Asha Scientific Works, Ambala	Disqualified because brochures are not attached with tender documents to evaluate.

The committee declared the below firms qualified subject to submission of an undertaking that the quoted items are meeting most of the specifications given in the tender document and if any of the item does not meet the specifications at the time of supply it will not be accepted. Only the bidder will be responsible for it and the Institute will not be responsible for anything in this regard.
