Revised Report of the Store Purchase Committee

The Tender Opening Committee opened the tender for Surgical Scrub for Operation Theatre against Tender Enquiry No. 24/OT/121(III)/2016-Rish(Admn) in front of participating bidders on 08/07/2016 and found that only 03 tenders received from following firms.:-

3	M/s Narula Udyog (india) Pvt. Ltd., New Delhi

After administrative evaluation of all the tenders received, Store Purchase Committee found that two firms fulfil eligibility criteria for qualification of technical bids and thus declared qualified for further technical evaluation. Other firm is declared disqualified because of the reasons mentioned below. M/S Instrumed India International, New Delhi is inadvertently declared disqualified in the previous report for less turnover however later it was found that the turnover was revised in the corrigendum to 30 lakhs per annum. Hence the firm is declared qualified for technical evaluation.

Since there are now two qualified bidders it is recommended that we may postpone/cancel the proposed opening of financial bid on **16-09-2016** and technically evaluate the bid of **M/s Instrumed India International, New Delhi** and if the firm is declared qualified we may also open the financial bid of both the firms.
