After consideration by Tender Committee following modification (deletions/additions/replacements) for Tender Enquiry No. F.No 24/Security Services/79/2015-Rish (Admn) have been done.

Srl No.2 at page-04:- Following is added after Para 2.1 – (III).

Or

Alternatively the firm/intending bidder should have applied for grant of License under Uttarakhand Government Private Security Agency (Regulation) Rules, 2005 before the date of publication of this tender and the same should not have been rejected by the Uttarakhand Government. In case of "Applied for" status, bidder should submit an affidavit on non judicial stamp paper of Rs. 100/ duly attested by the Notary Public declaring that the application submitted by him/them has not been rejected by the Uttarakhand Government. The copy of the acknowledged receipt of application made should be submitted along with the technical bid. In this case if the bidder is awarded the contract, it has to be ensured by bidder that he obtains the License under Uttarakhand Government within 90 days of award of work, failing which the Institute shall be at liberty to terminate the contract at the risk & cost of the bidder under no obligation of actual or deemed losses to the bidder.

Page 8:- Following is added:-

L1 will not be decided on Service charge of 0% and will be treated non responsive bid as per Office Memorandum issued by Ministry of Finance, Government of India. Service charge will be consisting of Uniform, electronic equipments etc.

Srl No. 8 at page 14:-

Read as: - The service provider shall be liable and responsible to provide all applicable benefits viz. Provident Fund, ESI, etc. to the staff engaged by him together with all related legal compliance. As far as EPF is concerned, the service provider will deposit the PF contribution with the Regional Provident Fund Commissioner, Dehradun against a sub-code acquired from the office of the Regional Provident Fund Commissioner, Dehradun through challan or separate cheque issued by AIIMS Administration and submit the acknowledgment of payment so deposited to the AIIMS, Rishikesh or as per instruction issued by EPFO from time to time. The service provider will be duty bound, in accordance with ESI act and will get the ESI cards issued by the competent authority in respect of all employees deployed by him and furnish ESI numbers to AIIMS, Rishikesh. Default on the part of the service provider will attract penalty as provided in clause 7(a).

Srl No. 47 at page 20:-

Read as:-Security supervisor shall be preferably of minimum rank of Ex-JCOs or equivalent in Police/Paramilitary force or with 5 years experience as security supervisor in a reputed organization.

Srl No. 48 at page 20:-

Read as:-The contracting agency shall employ preferably at least 15% manpower from the category of ex-servicemen not above the age of 50 years. The service provider shall provide honorable discharge proof ex-servicemen and AIIMS, Rishikesh shall get it verified on its own. However, no extra remuneration shall be payable for the said deployment by AIIMS, Rishikesh. Bidder is deemed to have considered all financial repercussions of deployment of ex-servicemen while quoting the tender.

Note: - The term and condition related to gratuity or bonus wherever is mentioned in tender document, may be considered as deleted.

Rest of specifications which are not mentioned here, remain unchanged as in original tender document.
