During the pre-bid meeting, certain objection/queries were raised. Accordingly, the bid conditions have been revised, and the corrigendum is as follows:

No other format for Earnest Money deposit would be accepted and such bid shall be rejected straightway.	It is clarified that EMD is exempted for Micro and Small Enterprises (MSEs) as per Public Procurement Policy for MSEs Order, 2012, subject to submission of valid Udyam Registration Certificate for Catering/Canteen Services. Where applicable, EMD shall be submitted only in the form of Bank Guarantee (BG) or Fixed Deposit Receipt (FDR) in favour of AIIMS Rishikesh. Demand Draft will not be accepted.
2	ISO Certification (Point 2(h) of Terms & Conditions)	Firm should be ISO 9001 and 14001 Certified before applying for Tender	Shall be read as "Firm should have ISO 9001 certification before applying for the tender."

Medical College/Hospital/Institutes of National Importance/ NIT/ IIT/ IIM/ IIIT / Central or State PSUs/ Central or State Autonomous Bodies/ Institutes managed by Central or State governments as per the attached experience proforma with this document in Annexure VI	Shall be read as "The bidder shall have at least 3 years of experience of canteen/cafeteria services in any Central or State Govt. Medical College/Hospital/Institutes of National Importance/NIT/IIT/IIM/IIIT/Central or State PSUs/Central or State Autonomous Bodies/Reputed Private Firms, as per the attached experience proforma with this document in Annexure VI."
