- 6. <u>Tenure:</u> Appointment is purely on contract basis initially for a period of 11 months or till regular appointment is made against these posts, whichever is earlier. This appointment will not vest any right to claim by candidate for regular appointment or permanent absorption in Institute OR for continued contractual appointment which may be renewed or terminated as decide by the Institute.
- 7. **Remuneration:** Consolidated pay shown against each post will be given to contractual appointee after statutory deduction.
- 8. **Expiry of Contract:** Contract will automatically expire on completion of 11 month until it is renewed with mutual consent for, he decided period. Contractual appointment can be terminated at any time by Institute. Employee can also leave Institute by giving 30 days' notice or salary in lieu thereof.
- 9. **Leave:** Leave entitlement of appointee shall be governed by Institute's leave rules as amended from time to time.
- 10. Competent Authority reserves the right to change number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- 11. Prescribed qualification is minimum requirement and mere possessing same does not entitle any candidate for selection.
- 12. Canvassing of any kind will lead to disqualifications.
- 13. Candidate may have to work in shifts and can be posted at any Place/Department of the Institute.
- 14. No travelling or other allowances will be paid to candidate for Written Test/Interview/Joining for post.
