- 1. Method of recruitment may be Written exam / Interview or both
- 2. The Selected candidate will have to join within 7 days of declaration of results.
- 3. It is NOT a permanent employment with AIIMS Rishikesh.
- 4. Appointment is purely on a contract basis (initially for period of 2/3 months). The extendable maximum duration of the appointment will be 6 months (Field data collectors) or 9 months (Research assistant) or till the duration of the project, whichever is earlier. The offered post is purely on a temporary/contractual basis for the specified period of time and based on the candidate's performance and a budget grant from the funding agency. The appointee's work will be reviewed time to time, and a future extension will be given based on performance.
