<b>TERMS AND CONDITIONS</b>	
<b>1.</b>	The tenderer must as per Lot for all the items in the list.
<b>2.</b>	On confirmation of the sale to the successful tenderer, the payment of full amount to be made within 10 days of receipt of Sale order (Confirmation of Sale) and pick up the material within two weeks of receipt of Sale Order.
<b>3.</b>	The successful Tenderer shall take delivery of Materials at accepted price. The amount shall be paid by the Tenderer by Crossed Account Payee Demand Draft on any nationalized bank payable drawn in favour of <b>"AIIMS Rishikesh"</b> . The removal of the Materials will be permitted only after payment of full amount and Delivery Order obtained from AIIMS, Rishikesh.
<b>4.</b>	All the charges i.e. loading, unloading and transportation to be incurred in course of lifting of items from the designated placed shall be borne by the successful bidder.
<b>5.</b>	In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles in the scheduled time, this office shall not take responsibility for safe custody of the articles.
<b>6.</b>	No damage shall be caused to the existing property of this office or any other offices in the premises while removing the materials from the site. Any loss/ damage to the property of this office or any other offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his authorized worker/ supervisor will be borne by successful bidder and they will be indemnified.
<b>7.</b>	In case the buyer wish to take Delivery of the Materials purchased, through a Representative, he must authorize the letter clearly by Name, by a letter of authority, with duly attested specimen signature to the Representative. AIIMS, Rishikesh however does not undertake any responsibility to the identity of the Representative and of wrong delivery.
<b>8.</b>	While taking delivery of the materials it will be at discretion of the authorized Representative of Company to decide the manner in which materials shall be removed. No segregation of the materials will be entertained at AIIMS premises.
<b>9.</b>	Goods/material will be removed under the supervision of designated officer(s) of this office. Materials will have to be removed within the time stipulated in acceptance letter. No extension of time will be given under ordinary circumstances. However, extension of time may be granted provided convincing and satisfactory reasons for such delay is given inwriting by the successful bidder. Delay, beyond the stipulated time, may entail cancellation of the award/order.
<b>10.</b>	Successful tenderers shall have to lift their approved Lots notified in Enclosure - II on (as is where is basis) within two (02) working days of the issue of the gate pass by Stores Section (Main Hospital Store) subject to full payment by the tenders, during working days (i.e. upto) 12.00 p.m. noon on Saturday and upto 4.00 p.m. in all working days) failing which a ground rent @ Rs. 1000/- per day will be charged till the final lifting of the goods by tenderes. No lifting will be permitted on Sundays and Govt. Holidays. Selected parties (highest bidder) shall be allowed to lift or load condemned goods only after issue of gate pass by the Store Section (Main Hospital Store). Space should be left clear after lifting their belongings by the approved vendor failing which EMD/BID SECURITY will be forfeited.

11.	<b>INSPECTION:</b> Tenderer can inspect the materials after submission of EMD.
12.	If a firm violates any of these terms & conditions, the same shall be blacklisted and other legal action may also be initiated.
13.	AIIMS Rishikesh will not be in any way responsible for failure to deliver the materials due to causes beyond their control such as Strikes, Cessation of labours, shortened hours of labours, acts of God or any cause or contingency whatsoever. The buyer shall not be entitled to cancel the Contract and the period of delivery shall automatically be extended accordingly.
14.	<b>Arbitration:-</b> The courts at Rishikesh/Dehradun will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other the court shall have jurisdiction in the matter.
