- All **Provisionally Eligible** candidates are required to submit the documents mentioned under the "Remarks" column either by Speed Post or in person on the day of document verification.
- Candidates will not be allowed to appear for document verification/interview without submission of the following required documents submitted through the proper channel (forwarded by the parent employer) prior to document verification:
  - No Objection Certificate (NOC)
  - Vigilance Clearance
  - Last 5 years' APR/ACR
  - Latest Salary Slip
- The eligibility status of the provisionally eligible candidates is purely tentative. Final eligibility will be deciding after document verification. If any candidate is found not fulfilling any of the eligibility criteria, as per advertisement, he/she will not be permitted to appear for the interview.
