- Candidates who have been marked as **Not Eligible** are hereby informed that, **if they have any objection/clarification regarding their eligibility**, they may appear in person to submit their representations along with relevant supporting documents during the documents verification process, one day prior to the interview, as per schedule to be uploaded on the *AIIMS Rishikesh website*. The decision of the committee, after re-scrutiny, will be final.
- All **Provisionally Eligible** candidates are required to submit the documents mentioned in the "Remarks" column either by Speed Post or in person on the day of document verification. Candidates who have already submitted the required documents may ignore this instruction.
- Candidates will not be allowed to appear for document verification/interview without submission of the following required documents submitted through the proper channel (forwarded by the parent employer) prior to document verification:
 - (i) No Objection Certificate (NOC)
 - (ii) Vigilance Clearance
 - (iii) Last 5 years' APR/ACR
 - (iv) Latest Salary Slip
- The eligibility status of the provisionally eligible candidates is purely tentative. Final eligibility will be deciding after document verification. If any candidate is found not fulfilling any of the eligibility criteria, as per advertisement, he/she will not be permitted to appear for the interview.
- Only those candidates who will confirmed as eligible after document verification will be allowed to participate in the interview.
