- Such representation shall be restricted only to the documents already submitted within the bid submission deadline. **No fresh documents shall be accepted under any circumstances.**
- The Technical Evaluation Committee shall examine the representations received, if any, and submit its recommendations to the Competent Authority. The decision of the Competent Authority shall be final and binding.
- In view of the time-bound nature of the procurement, no representation shall be entertained after the stipulated period.
- Original documents of the successful bidder shall be verified prior to award of contract. However, the responsibility of correctness, genuineness, and authenticity of all documents submitted (online or offline) shall rest solely with the bidder. In case any document/information submitted by the bidder is found to be false, forged, fabricated, or misleading at any stage of the tender process or during execution of the contract:
 - i. The bid/contract shall be liable for immediate rejection/termination;
 - ii. EMD/Performance Security shall be forfeited;
 - iii. The bidder shall be liable for blacklisting/debarment as per Government norms;
