Job Profile: The Research Fellow will be responsible for

- Carrying out patient recruitment in selected areas of Uttarakhand, obtaining informed consent, training of Households for HBPM
- Maintaining the record of the data in presentable form (soft as well as hard copy).
- Tracking contingencies/consumables required for the work.
- Assisting the PI in the preparation of various reports and statistics related to the research work.
- Coordinating hypertension awareness workshops/public lectures and similar work as directed by PI and team.

Mode of Application: Interested candidates must apply with a brief bio-data mentioning their educational qualifications (Class X onwards) with percentage/CGPA obtained at each level and research experience (if any) via email to the principal investigator on or before the application deadline. Scanned copies of supporting documents need to be attached to the email. *Please write "Application for JRF" in the subject line of the email.*

Mode of selection: Only shortlisted candidates will be intimated, and selection will be based on his/her performance in personal interviews by a selection committee. No TA/DA will be paid for this purpose.

Terms And Conditions:

- Method of recruitment may be Written exam / Interview or both
- The Selected candidate will have to join within 5 days of declaration of results.
- It is NOT a permanent employment with AIIMS Rishikesh.
- Appointment is purely on a contract basis for an initial period of 12 months (Twelve Months). The extendable maximum duration of the appointment is for two years or till the duration of the project, whichever is earlier. The offered post is purely on a temporary/contractual basis for the specified period of time and based on the candidate's performance and a budget grant from the funding agency. The appointee's work will be reviewed after twelve months, and a future extension will be given based on performance.
- NO claim for any other regular post in AIIMS Rishikesh shall be entertained.
- Employee Performance Indicator will be applied.
- Candidate must bring the completely filled application form at the time of interview.
- Incomplete applications or applications received after the due date will not be considered.
- No TA/ DA will be paid for the interview.
- Experience should have been gained after acquiring minimum essential qualification.
