#### **Terms & Conditions:**

- The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
- EMD shall be prepared in Form of DD/FDR/TDR from any nationalized/scheduled bank and drawn in favor of **“ALL INDIA INSTITUTE OF MEDICAL SCIENCES RISHIKESH”** and should be valid up to 180 days from the date of work order. (Note: EMD exempted for MSME bidders registered in manufacturing as per govt. rule)
- Rates must be quoted as per the format specified Taxes extra if any must be written separately.
- No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- Becoming L1 will not be the criteria for awarding of purchase order/work order unless the rates are reasonable & justified. L1 will be decided on individual item basis.
- RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.

- The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
  - The firm shall have valid GST and PAN number.
  - The firm should not be black listed by any Government Department
- Work Period – 02 days from issuing Work Order.
- Liquidated Damage: - If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
- Payment Terms: Payment will be made only after satisfactorily delivery, Installation, Testing commissioning and inspection of material by the AIIMS Rishikesh.
