All India Institute of Medical Sciences, Rishikesh offers broad-based research programs leading to award of Doctor of Philosophy (PhD) degree. Research work may exemplify development of new interventions, testing of new scientific ideas or gaining insight into biological processes.

Degree of Doctor of Philosophy (PhD) would be awarded to a Candidate, who, as per these regulations, has submitted a thesis on basis of original research work done by him/her in any discipline specific or multi-disciplinary area that makes a contribution to advancement of knowledge in Medical, Nursing and Allied Health Sciences or innovates methods of application of existing knowledge in Medical, Nursing and allied Health Sciences so as to contribute to betterment of humanity. Basic object of PhD course is to develop scientific capacities of researchers and scientists in field of Medical, Nursing and Allied Health Sciences. Institute provides excellent opportunities for research work in modern era of 21st century with state of art infrastructure, laboratories and equipment.

Eligibility criteria for admission to Ph.D. Course:

A Candidate seeking admission to course of study leading to award of a Degree of Doctor of Philosophy must possess at least one of following qualifications of a recognized University/Institute:

1. For Medical Sciences:

- I. MBBS /BDS degree or equivalent with minimum of 55% aggregate marks or Equivalent percentile in Professional examinations
- II. MD/MS/MDS/DM/MCH in Subject concerned or Diplomate of National Board of Examinations or equivalent degree recognized by MCI/DCI.
- III. Master degree after BAMS, BHMS, BNYS for PhD in AYUSH.
- **2. For Nursing:** Candidates holding MSc degree with minimum 55% aggregate marks or equivalent percentile in Nursing specialty will also be eligible for PhD admission in College of Nursing.
- 3. For Non Medical: Master degree (02-year course) awarded by Indian University or equivalent in subject as per requirement of project. Candidates holding MSc (Other than MSc Nursing), M Biotech/ M Tech degree / M Com / MBA/ MPH will be eligible for non-medical qualification category as per AIIMS Delhi. Candidates possessing Master's Degree through distant learning course shall not be eligible. Candidates having eligibility under non-medical category should have at least 55% marks or equivalent in last eligibility examination qualified.

Non-medical candidates should have preferably qualified in any one of following national entrance tests in last 2 years:

- Joint CSIR-UGC NET for JRF
- ICMR JRF
- ICMR-SRF
- DBT JRF
- DBT SRF
- NBHM screening test
- Graduate aptitude test (GATE)
- INSPIRE fellowship
- UGC JRF
- UGC SRF
- CSIR JRF
- CSIR SRF
- DST JRF
- DST SRF

Relaxation in Qualification for all Candidates.

A relaxation of 5% of marks from 55% or an equivalent relaxation of percentile / grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled and female Candidates.

For External Candidates in permanent employment:

I. Candidates who are permanent employees of external Institutions (Central Govt/ Semi Govt/ Autonomous organization) should submit application through proper channel. i.e. employer. They will be required to submit a 'No Objection Certificate" from their employer before they are allowed to join the Ph.D. Course

II. Also, such Candidates will have to provide a certificate at time of submission of synopsis from employer stating that in event of selection to PhD course, Candidate will be granted for a minimum period of 03-year study leave with full pay and permission to work at AIIMS Rishikesh to pursue full time PhD Course.

In-service- Candidates

Applicants from AIIMS Rishikesh – Only those faculty/scientists/administrative officer/officials, whose tenure
is of 3 years or more (subject to fulfillment of eligibility criteria) will be allowed to apply as internal
candidate. DM, MCh, PDCC candidates and others pursuing full time academic courses at AIIMS Rishikesh
cannot apply for a PhD programme simultaneously.

If a faculty has consented to be guide of a scholar, he/she will not be eligible to apply for PhD Course as a PhD scholar until submission of thesis work by research scholar under him/her.

Transfer for PhD credit in case of relocation

- In case of relocation of PhD scholar due to marriage or otherwise, research period, and research data shall be allowed to be transferred to AIIMS Rishikesh. Scholar will give due credit to parent guide and previous Institution for part of research already done.
- Subject to condition that Research Scholar has either joined as employee/ on deputation and has cleared entrance exam conducted by AIIMS, Rishikesh and is willing to enroll as a full time PhD Research Scholar.

Please Note: Candidates who are likely to complete the requisite qualification and degree by 20.05.2022 may also apply. All such candidates must submit a certificate on the letterhead of the College/Universities, signed and stamped by the Registrar/Dean/Principal confirming that the candidate is likely to complete the eligibility qualification by 20.05.2022. Candidates who are completing their requisite qualification after **20.05.2022** are not eligible to take this examination.

Duration of Course

- i. Duration of course for all Candidates will commence from date of declaration of entrance examination result (provisional registration) to award of degree.
- ii. PhD course will be full time.
- iii. Duration of three years' course will include previous research experience for transferred Scholars and faculty.
- iv. Minimum Duration: Shall be for a minimum period of three years including course work.
- v. Maximum Duration: Shall be for a period of 6 years.

Online Applications starts from **06 June 2022** & last date of receiving of online application form is **26 June 2022 by 05:00 PM**.

Candidates applying for PhD seats in extramural projects should have qualified in any one of the following entrance tests in last two years: Joint CSIR-UGC NET for NBHM screening test, graduate aptitude test (GATE), ICMR, DBT, and INSPIRE fellowship.

Internal candidates may apply under any Department after ensuring availability of a guide from the respective department in the institute.

Important Notes: Candidates may apply for PhD in one subject only. Candidates will be eligible ONLY for seats in the department that they have applied for. Candidates will be allocated seats in order of their merit in the exam. Successful candidates will be screened for eligibility criteria of respective Project before admission. Candidates who are allotted a seat but do not join or resign after joining will not be eligible for any additional rounds of seat allocation. Candidates will be allocated seats in order of their merit in the exam. PhD Scholars are required to make their own arrangements for stay at their own expenses during the period of their PhD Course. They are also required to identify source of funding support for their research work, as Institute will not support PhD Scholar (External) for their stay/salary/ research funding support.

Method of selection:

All Internal and External candidates (Medical, non-medical, in-house, in-service, transfer-in etc.) will have to appear in two stages of entrance exam:

Stage 1: Written entrance Exam

Stage 2: Departmental assessment and interaction with IRRB

Entrance to PhD Course will be based on merit scores based on following evaluations:

Entrance Exam: 200 Questions of 3 hours duration of 200 Marks (Common for all Speciality):

Special weightage:

A: Medical / Dental/ Nursing candidates:

10 marks as special weightage extra will be added to total score of Candidates who fulfil both the following criteria:

- (1) Those candidates who have scored at least 50% in Stage I.
- (2) They hold a Medical Degree (MBBS/ BDS/ MDS/ DNB/ MD/ MS/ DM/ M.Ch.) or M.Sc. (Nursing).

B: Non-Medical candidate

10 marks will be added to the total score of Stages I and II for candidates who fulfill both the following criteria:

- 1. They are eligible for stage II.
- 2. They also have qualified in any one of the following National Entrance Tests leading to the award of a fellowship tenable at AIIMS, Rishikesh in the last 2 years (January 2020 to January 2022):

- Joint CSIR-UGC NET for JRF
- o ICMR JRF
- o ICMR-SRF
- o DBT JRF
- o DBT SRF
- o NBHM screening test
- Graduate aptitude test (GATE)
- o INSPIRE fellowship
- o UGC JRF
- o UGC SRF
- o CSIR JRF

- o DST SRF

To be eligible for special weightage marks, ALL the following criteria must be fulfilled:

- The result of the above listed National Entrance Tests must have been declared between January 2020 and January 2022
- The award of the fellowship must be based on the result of the above listed National Entrance Tests.
- The fellowships should be tenable at AIIMS, Rishikesh.
- The letter of award of fellowship must be uploaded with the application form. Passing of the listed National Entrance Tests is not acceptable as proof of award of fellowship.

Candidates must score at least 50% marks in Stage I to be eligible for Stage II of entrance exam. Final Score will be computed as follows:

- 80% Entrance Examination Score
- 20% Departmental assessment & interaction with IRRB

Evaluation Procedure

Each correct (MCQ) answer will be awarded 1 mark. More than one answer will be treated as wrong answer. Zero mark will be given for questions not answered or marked for review.

Note:

- I) Result will be available on website of AIIMS Rishikesh. No individual intimation will be communicated to Candidate.
- II) Whose candidature is not approved by Institutional Research Review Board will not be eligible for admission.
- III) Admission to Ph.D. Course will be subject to availability of Guides/ research funds/fellowship/ grant from recognized funding agencies.

If any discrepancy in any question is found in the Entrance Examination, the candidate is advised to write to Dean (Exam), AIIMS, Rishikesh within 24 hours on the following email: exam@aiimsrishikesh.edu.in. This mail will only be used for discrepancy related to question. However, for other query please mail on phd@aiimsrishikesh.edu.in

Note:

- I) The combined result of Stage-I & stage-II will be available on website of the Examination Section, AIIMS and on website of AIIMS Rishikesh. No individual intimation will be communicated to the candidate.
- (II) Candidates who fail to attend any of the stages of examinations as mentioned above will not be eligible for admission.
- III) Admission to Ph.D. Course will be subject to the availability of research funds/fellowship/ grant from recognized funding agencies. After declaration of results, selection letters will be issued by the Academic Section only to those candidates who have submitted Undertaking/Proof of their funding sources through concerned Head of the Departments.

Final Result of qualified Candidates will be prepared based on number of vacancies available and availability of approved Guides and Co-guides. Final result of selected Candidates will only be declared after getting approval from Competent Authority, AIIMS Rishikesh. Selected Candidates are required to join within last date of joining as mentioned in Result information uploaded on Institute website. In case Candidate fails to join by this date and no written request for extension is received, it will be assumed that he/she does not intend to join course and seat will be

offered to next Candidate on waiting list. No further correspondence will be entertained in this regard. The maximum duration of extension that may be provided to a candidate after approval by Director AIIMS Rishikesh is one month from the last date of joining.

Indemnity Bond:

All Candidates enrolled for PhD Course shall sign a bond for completion of course. Leaving course in mid-way will involve recovery of salary/fellowship and a fine up to Rs 2 lakh based on decision of DRC. However, Candidate can request Director AllMS Rishikesh for review of decision of DRC.

Allocation of Guide:

Candidate shall work under supervision of a recognized Ph.D. guide of AIIMS Rishikesh. Candidate for Ph.D. Course shall have option to choose his/her research guide of AIIMS Rishikesh. Allocation of guide will be done by IRRB, from the department in which the candidate has applied for Ph.D within a department preference will be given to a faculty with an extramural project funding. The number of Ph.D candidates in a department will be equally distributed among the eligible faculty. Co-guides will be selected by the guide and scholar based on subject expertise required for PhD thesis. At least one co-guide from the concerned department should be included. Only a full-time regular teacher/Director of AIIMS Rishikesh can act as a supervisor.

External Guides are not allowed. However, Co-Guide can be allowed in inter-disciplinary areas from other departments of AIIMS Rishikesh or from other related Institutions with approval of DRC. Research Guide should have at least four years teaching/research experience after acquiring PG qualification in respective field. Any regular Professor / Director with at least five research publications in peer reviewed journals and any regular Additional/Associate/Assistant Professor with at least two research publications in peer reviewed journals may be recognized as Research Guide. Provided that in areas/disciplines where there is no or only a limited number of journals, Institution may relax above condition for recognition of a person as Research Guide with reasons recorded in writing. Faculty perusing his/her PhD at AIIMS Rishikesh will not be eligible to be a guide simultaneously for any other PhD Candidate during his/her own PhD course.

Registration Process: Date of declaration of result shall be treated as Crucial/due date of provisional Registration.

Method of Resolving Tie: The tie cases will be resolved according to age (Date of birth), the older candidate shall get preference over the younger one.

Joining: Selected candidates are required to join <u>as per the date given in his/her provisional offer letter</u>. In case the candidate is not granted an extension for joining and fails to join by the date given to him/her in provisional offer letter, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list. No further correspondence will be entertained in this regard.

IMPORTANT

The Ph.D. Seats shall lapse if the selected candidates do not join by **31**th **August, 2022** for July session. No candidate shall be allowed to join after **31**th **August, 2022** for July session.

IMPORTANT INSTRUCTION APPLICABLE TO Ph.D. PROGRAMME EXAMINATION:

- 1. INSTRUCTIONS FOR FILLING THE ONLINE APPLICATION FORM: Candidate should fill in the Online Application Form taking utmost care. Candidate should fill in the Online Application form correctly. Incorrect filled form may lead to rejection.
- 2. ONLINE REGISTRATION & SUBMISSION OF APPLICATION FORM: A candidate seeking admission to the Entrance Examination is required to submit his/her application in the prescribed format available online with the Prospectus on https://aiimsrishikesh.edu.in The cost of Application Form includes the fee for entrance examination which is non-refundable and no correspondence in this regard will be entertained. The candidate is required to go through the Prospectus carefully and acquaint himself/herself with all requirements with regard to filling of the online application form.

Online Registration: After selecting the online registration, fill the mandatory details asked for and deposit the prescribed fee through debit/credit card/Net Banking. After submitting fees filled required information step by step. Follow the Instructions scrupulously. It will be the responsibility of the candidates to ensure that correct details are filled in the Registration Form. The Institute will not be responsible for any incorrect information/cancellation of candidature/loss or lack of communication etc. due to wrong filled online Application form.

No candidate should register more than one application.

Duplicate applications from any applicant will result in cancellation of all such applications. No intimation regarding such summary rejections will be provided.

STATUS OF ONLINE REGISTRATION

Acknowledgement of successful Online Registration will be forwarded to applicant's Registered Email ID. The candidates are advised to check final status of their Registration Form regarding images and eligibility and Admit Card which will be available on AIIMS website as per the schedule mentioned in the "IMPORTANT DATES AT A GLANCE".

Admit Card for Accepted Registration Form will only be uploaded on the website. If the status of Registration Form or Admit Card is not available on website, he/she should immediately write an email to the Dean Examinations, AIIMS, Rishikesh on exam@aiimsrishikesh.edu.in with full particulars of the Registration Form.

SUBMISSION OF APPLICATION BY CANDIDATES WHO ARE EMPLOYED:

The candidates in employment applies for Ph.D. Program are required to submit their applications through proper channel. They should also sign the undertaking in the downloaded copy of Registration Form that they have informed their employer about the submission of the application to AIIMS. If any communication is received from their department/office withholding permission to the candidate's appearing at the entrance examination/admission to the course, the candidature/admission of the candidate will be cancelled, and no further correspondence in this regard will be entertained. (Internal candidates for Ph.D. Program are required to route their Registration Form through proper channel).

PROCEDURE FOR REDRESAL OF DISCREPANCY NOTICED:

- (i) If any discrepancy in any question is found in the Entrance Examination, the candidate is advised to write to Dean (Exams), AIIMS, Rishikesh within 24 hours on exam@aiimsrishikesh.edu.in.
- (ii) Discrepancy, if any, in the Prospectus, Admit Card etc. should be immediately brought to the notice of the **Dean (Examinations) AIIMS, Rishikesh** through email exam@aiimsrishikesh.edu.in Complaints received after the examination will not be entertained.
- (iii) It will be the responsibility of the candidate to ensure that correct address, Mobile No. & email ID in the Application Form is filled. The Institute shall not be responsible for any miscommunication due to incorrect address, Mobile No. and email ID given by the applicant on the Application Form or non-receipt for any communication.
- (iv) Downloadable Admit cards of all the eligible candidates will be hosted on AIIMS Rishikesh website as per the schedule mentioned under 'AT A GLANCE'. All the candidates are advised to download their Admit Cards from the website. It may please be noted that the Admit Cards will not be sent by Post.
- (v) Any Change in the address, mobile No. and email ID should be immediately intimated to this office by registered mail. Candidate should also ensure that any communication sent at the previous address is redirected to him/herat the new address.
- (vi) If a candidate is at any stage found to have provided false information/certificate or is found to have withheld or concealed some information in his/her application form, he/she will be debarred from admission, his/her Candidature will be terminated with immediate effect.
- (vii) If ineligibility is detected at any stage, candidature/admission of the candidate will be cancelled without any notice.
- (viii) Candidate must not obtain or give or attempt to obtain or give irregular assistance of any kind during the examination; this will entail expulsion and cancellation of candidature for the examination. The admission of the candidate will be cancelled and appropriate criminal/civil proceedings will be initiated against the candidates, if at any stage of the examination the candidate is found to have secured admission by using any unfair means.
- (ix) The Institute will not intimate the result of Entrance Test individual. No correspondence in this regard will be entertained. However, the marks of individual candidate will be made available on AIIMS Rishikesh website on completion of the admission process.
- (x) There is no provision for re-checking/re-evaluation of the answer sheets and no query in this regard will be

- entertained.
- (xi) The decision of the Director of the Institute shall be final in the matter of selection of candidates for admission to Ph.D. Program and no appeal will be entertained in this regard.
- (xii) Selected candidates must join the course on the date stipulated in the letter of selection, failing which the selection/admission shall stand cancelled/withdrawn.
- (xiii) The selected candidates will have to submit the original Certificates at the time of joining.
- (xiv) The selection of **students in Ph.D. Program** will be subject to medical fitness. No selected candidate will be permitted to pay fee/join the course unless declared medically fit by the Medical Board appointed by the Institute. The decision of the Medical Board shall be final.
- (xv) Each candidate selected for admission shall have to pay the fee/dues within the prescribed period failing which his/her admission shall be cancelled.
- (xvi) Private practice in any form during the course is prohibited. The period of training is strictly full time and continuous.
- (xvii) The rules are subject to change in accordance with the decision of the Institute to be taken from time to time.
- (xviii)Any dispute in regard to any matter referred to herein shall be subject to the jurisdiction of Nainital Court, Uttarakhand.
