- **3.** Those contractors not registered on the website mentioned above, are requested to get registered beforehand.
- **4.** The intending bidder must have valid class-III digital signature to submit the bid.
- **5.** On opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.
- **6.** Contractor can upload documents in the form of PDF Format.
- **7.** Contractor must ensure to quote rate in the prescribed columns meant for quoting rate in figures.

However, if a bidder quotes nil rates against each item in item rate tender, the tender shall be treated as invalid and will not be considered as lowest bidder.

- 8. List of Documents to be scanned and uploaded within the period of bid submission:

Earnest Money in the form of Treasury Challan or Demand Draft or Pay order or Bankers Cheque or Deposit at Call Receipt or Fixed Deposit Receipt (drawn in favour of AIIMS Rishikesh shall be scanned and uploaded to the e-tendering website within the period of tender submission. The original EMD should be deposited either in the office of Executive Engineer inviting bids.
- II. Certificate of Registration for GST.
- III. Singed with company seal on each pages of NIT and documents uploaded with bid.
- **9.** Only Authorized signatory will be permitted to sign any type of documents.
- **10.** The soft copies of documents uploaded by contractors on CPP Portal.

TREMS AND CONDITIONS

1. Technical bids submitted by the bidder will be opened first and evaluated for fulfilling the Prequalification criteria and other conditions in NIT/Tender documents, based on documentary evidences submitted along with the offer.

2. Security Deposit:-

Security Deposit 5% of tendered value will have deducted by the AIIMS Rishikesh, the following shall be complied with:

a) Security deposit will be deducted from Running bill/ Final bill of the contractor.

3. Return of Security Deposit:-

Security Deposit will be released to the Contractor after deducting all expenses /other amounts due to AIIMS, penalty amount if any, after defect liability/warranty/ guarantee period of the contract.

4. Payment Terms: -

100% payment after successful Supply, submission of e-way bill and gate entry pass. Standard deduction as per the govt. rules / as per NIT.

- 5. Payment will be made as per terms and conditions of tender document. However, it maydepend on availability of funds. It can be delay due to scarcity of funds.
- 6. Compressor shall be brand new, manufacturing year- 2022 and warranty period shall be minimum 1 year.
- 7. All items/materials shall be approved by Engineering in charge before delivery to site failing which the material shall be rejected and EMD will be forfeited.
- 8. All items/materials shall be of superior quality.
- 9. L1 will be decided on total amount.
- 10. The rates quoted must be valid for 90 days minimum from the last date of bid submission.
- 11. Period of supply 15 days from issuing Purchase Order.
- 12. Price quoted shall be Inclusive of all Taxes & duties.
- 13. Price quoted shall be FOR Basis at AIIMS Rishikesh.
- 14. Liquidated Damage: If the contractor fails to supply within 15 days after issuing Purchase order, then a penalty at the rate of 0.5 % per week of the total purchase order value shall be levied subject to maximum of 10% of the total purchase order value.
- 15. Disputes: -In the event of any dispute or disagreement arising between the Supplier and AIIMS Rishikesh with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to the Director, AIIMS Rishikesh whose decision will be final and binding upon the Supplier.
