ELIGIBILITY CRITERIA

1 Essential Educational Qualifications

Candidates must possess, a requisite qualification **RECOGNISED** by **National Medical Commission, India**. Postgraduate degrees from Departments / Institutions to which NMC, India recognition has not been formally granted (for example: under consideration) will not be considered and candidature of applicants with such degrees may be rejected at any stage (including after admission if this fact comes to notice at that stage).

Eligibility criteria for PDF Courses:

- MD/MS Postgraduate degree or other Equivalent Degree recognized by the National Medical Commission, India in respective discipline.
- The candidates must have completed the requisite qualification, degree, tenure and experience (if applicable) by 31.07.2026. The candidates who are likely to complete their “3 years (365×3) = 1095 Days” tenure (from a single medical college only), qualification or degree and experience (if applicable) after 31.07.2026 will not be eligible to appear in this examination. If such candidates appear in examination by submitting incorrect/false information, they shall be declared ineligible at any stage of the selection process.
- Preference will be given to students with Post-PG experience. Students will be given advantage in **Departmental Assessment** as follows:
 - Extra 10 marks for 2 years senior residency

2. Extra 5 marks for 1 year senior residency
3. No extra marks for students without experience of seniors residency

(d) Eligibility criteria only for PDF Lifestyle Disease Management sponsored candidate:

- The eligible candidate must be Medical officers with Post MBBS Clinical experience of working in state PHC/CHC for minimum 2 years.

RESERVATION

There is no reservation in Fellowship program. Candidates will be considered against vacancy of senior residents in respective departments.

4. SCHEME OF MARKING

- There will be no negative marking in written examination.
- No credit will be given for questions not answered.

5. METHOD OF SELECTION

Selections for Fellowship courses are made through written examination & interview.

If any discrepancy in any question is found in Entrance Examination, candidate is advised to write to Dean (Examination), AIIMS, Rishikesh within 24 hours of completion of examination on following email: E-mail rec.exam@aiimsrishikesh.edu.in. This mail will only be used for discrepancy related to question. However, for any other query please mail on deanacademics@aiimsrishikesh.edu.in.

Stage I: Written test carrying 60 marks of 90 minutes duration in subject candidate has applied for. Question paper will consist of 80 Multiple Choice Questions (MCQs).

Candidates who secure $\geq 50\%$ marks in Stage I shall be eligible for the Stage II examination (Approved in 12 AC).

Stage II:

- Based on merit list from Stage I, candidates 3 times number of seats advertised will be called for departmental clinical/practical/lab based assessment (Carrying 40 marks).**
- Candidates who secure $\geq 50\%$ marks in stage I & II combined shall be considered eligible for admission and shall be included in the final merit list (Approved in 12 AC).**

Final Selection: Final result will be declared based on total marks obtained in stage-I and stage-II Examination. weightage of the Entrance examination to be as : 60% (Theory, Stage I) and 40% (Departmental Assessment, Stage II).

Note: I) Result of written examination will be available on website of AIIMS Rishikesh. No individual intimation will be communicated to candidates.

II) Candidates who fail to attend any of two stages mentioned above will not be eligible for admission.

III) Selected candidates are required to join on or before 14.08.2026. If selected candidates will not join in the stipulated time then offer will be sent to waitlist candidate.

IV) Last date for admission to Fellowship Course will be 31.08.2026. In any circumstances, last date for admission will not be extended beyond 31.08.2026.

6. METHOD OF RESOLVING TIES

According to age (Date of birth), older candidates shall get preference over younger one.

7. EMOLUMENTS

Senior Resident Post, if available, may be provided to Post-Doctoral Fellowship candidate as per institute rule. Sponsored Candidates are not eligible for emolument.

8. LEAVE

First year: 30 days, Second year: 30 days,

- a. Leaves availed by candidates beyond permissible limit (per year) shall be treated as Extra Ordinary Leaves (EOL) without pay. The Extraordinary Leaves can be availed up to maximum of 30 days in the tenure. But the candidate will have to work for the extended period equivalent to that of EOL.
- b. In case EOL availed are more than 30 days the Residency will be extended for the similar period and final examination of the candidate shall be held with next batch.

9. Maternity Leave

Female Residents (Fellowship) are entitled for maternity leaves as per Govt. of India rules during their course with full pay. Their period of registration/training will be extended for equivalent period. Post-Doctoral Fellowship Candidate will have to work for extended period and final examination of candidate shall be held with next batch.

10. Paternity Leave

Male Residents (Post-Doctoral Fellowship) are entitled for paternity leave as per Govt. of India rules.

11. Unauthorised absence of students:

Unauthorised absence of students will be informed to Students and also Parents or Local Guardians. At least 3 reminders will be issued with a gap of 10 days by Academic Section to these students. Thereafter action of cancellation of registration of concerned will be decided by Dean/ Director, AIIMS.

12. Penalty

Original certificates of all candidates will be retained in Academic Section at time of joining. Same will not be returned before completion of course unless he/she deposits a sum of Rs. 50,000/- (Rupees Fifty thousand only). If any candidate who joins Post-Doctoral Fellowship course, leaves said course within six months of joining, he/she shall be liable to pay a sum of Rs. 50,000/- (Rupees Fifty thousand only) and after six months shall be liable to pay a sum of Rs. 1, 00,000/- (Rupees one Lakh only) as compensation

for losses incurred by AIIMS due to such midstream departure. Salary for month in which his/her registration from course becomes effective, shall also stand forfeited.

13. HOSTEL ACCOMMODATION

Candidates will be provided hostel **subject to availability**.

E. Administrator/Secretary to Administrator/Development Officer (Lakshadweep Island) or as authorised in Constitution.

Candidate will be required to submit an undertaking to effect of their caste. Detection of any discrepancy in caste certificate shall entail cancellation of registration. G. PWBD Candidates must note that a certificate from any other person/authority will not be accepted and no further correspondence in this regard shall be entertained. Name, designation and seal of officer should be legible in certificate.

3.SUBMISSION OF APPLICATIONS BY CANDIDATES WHO ARE EMPLOYED

Institute does not have any objection if candidates in employment apply for above postgraduate course (except candidates for sponsored seats) submit their applications directly i.e. they are not required to submit their applications through proper channel). However, all such candidates should inform their employer in writing that they are applying for this Entrance Examination. They should also sign Undertaking that they have informed their employer about submission of application to AIIMS. If any communication is received from their department/office withholding permission to candidate's appearing at entrance examination/admission to course, candidature/admission of candidate will be cancelled, and no further correspondence in this regard will be entertained. **(Sponsored candidates are required to route their Registration Slip through proper channel).**

4. REQUIREMENTS FOR ADMISSION OF “SPONSORED” CANDIDATES

- a) Candidates who are permanent employees of any Central/State Government/Armed Forces or Public Sector Undertaking/Autonomous Body can be sponsored by respective Government/Defence Authorities or Competent Authorities of PSU/Autonomous Body.
- b) All eligible “sponsored” candidates will be called by Institute for an entrance test.

1. Subject for which candidate is being sponsored should be clearly specified in sponsorship form by sponsoring authority. Candidate can be sponsored for only

one subject. Applications of those candidates who are sponsored for more than one subject will not be considered.

2. “Sponsored” candidate will not be paid any emoluments during training period. Such payments will be responsibility of sponsoring authority (i.e. Central/State Government or Defence Authorities).
3. Sponsored candidates must submit/send sponsorship certificate in original from their employers in attached format along with application form. Those who fail to do so their candidature will be cancelled.

5. GUIDLINES FOR REGULAR AIIMS RISHIKESH FACULTY FOR POST-DOCTORAL FELLOWSHIP (PDF) PROGRAMME UNDER SPONSORED CATEGORY:

1. Members of medical faculty can apply for registration to PDF course as in-service candidate.
2. Faculty should be a regular employee of Institute & should have rendered a minimum of 5 years continuous service as faculty at Institute.
3. Candidate admitted under this category will be considered as in service candidate provided Head of Department certifies that (a) such training will help in patient care/teaching/research of Department (b) work of department will not suffer and no additional staff will be asked for.
4. Faculty member who has registered himself/herself as PDF course/ fellowship will not be allotted new candidates for Guide/Co-Guide of any other Post-Graduate course in concerned department during time he/she is undergoing course.
5. (a) Faculty members may apply through proper channel as sponsored candidates and appear for entrance examination.
6. (b) Through proper channel for open entrance examination if sponsored seat are not available.
7. Candidates selected for pursuing said course have to pay PDF fee etc.
8. Faculty member has to execute a bond that he/she will serve institute for a period not less than five years after completing said course failing to which they are liable to return total salary, allowances and any amount paid to them by institute during their course along with a penalty amount of Rs.20 Lakhs. In case of violation of compliance of provisions of executed bond appropriate legal action shall be initiated against defaulters.
9. During period of course, in-service/faculty member will be treated as on study leave.

10. Period of study leave for said course within same Department or within AIIMS will be counted for purpose of A.P.S. Those who are availing study leave for courses outside AIIMS period will not be counted for A.P.S.
11. Candidate/faculty will not be entitled for winter/summer vacation during entire course and he/she will be eligible for leaves as per Residency Scheme.
12. Duties/Responsibilities of trainee will be as per Residency Scheme.
13. In-service candidates will have option to pursue this course in any related specialty, subject to availability of seats and forwarding of their applications through proper channel.
14. Candidate/faculty will be allowed to avail of study leave for pursuing PDF courses only one during entire service.

6. REQUIREMENTS FOR ADMISSION OF FOREIGN NATIONALS/OVERSEAS CITIZEN OF INDIA (OCI)

a) Foreign nationals are required to fill in prescribed application form indicating choice of subject (only one subject) for admission to Postgraduate courses leading to **Post-Doctoral Fellowship (PDF) Entrance Examination**.

b) **Foreign nationals are required to send their application through Diplomatic Channel (NOC from Ministry of External Affairs and Ministry of Health & Family Welfare, Govt. of India).** They are also required to appear in Competitive Entrance Examination along with other candidates. An 'Advance Copy' to be submitted at AIIMS, Rishikesh on or before last date of submission of application. However, application of all such candidates will be processed only after receipt of same through Diplomatic Channel.

c) Foreign nationals will be considered against seats advertised under **"Sponsored"** category for **Post-Doctoral Fellowship (PDF) Entrance Examination** courses. They should be registered with **National Medical Commission, India** before they will be allowed to join said course, if they are selected for same.

1. Seats are not reserved in any discipline for foreign nationals.
2. Nominations/No objection for candidate should reach Examination Section before date of issue of Admit Card as specified under "AT A GLANCE". In case of non-receipt of nominations/clearance/no objection from concerned Ministry by due date, their candidature will not be considered.
3. No emoluments will be paid by AIIMS to Foreign National candidates.

g) **OVERSEAS CITIZEN OF INDIA (OCI):** OCI registered under Section 7A of Citizenship Act 1955 are also eligible to appear in PG courses and all terms and conditions applicable for Indian Nationals will be applicable to candidates. Candidate will submit proof of Registration as OCI under Section 7A of Citizenship Act 1955 to be eligible to appear for this test.

7. PROCEDURE IF THERE IS ANY DISCREPANCY NOTICED:

Discrepancy, if any, in date and time of entrance examination mentioned in Prospectus, Admit Card etc. should be immediately brought to notice of Dean (Academics), AIIMS, Rishikesh through email. Complaints received after examination will not be entertained. In case any discrepancy is found in information provided in various documents, data provided on Application Form will be considered as final for all purposes.

It will be responsibility of candidate to ensure that correct address, Mobile No. & email ID in Application Form is filled. Institute shall not be responsible for any miscommunication due to incorrect address, Mobile No. and email ID given by applicant on Application Form or non-receipt for any communication.

Any Change in address mobile No. and email ID should be immediately intimated to this office. Candidate should also ensure that any communication sent at previous address is redirected to him/her at new address.

GENERAL INFORMATION

- One candidate can apply only one speciality.
- Date, time and venue of examination will be provided on admit card.
- No TA/DA shall be paid for appearing in entrance examination or for joining.
- Number of seats/posts indicated in advertisement for various programs is provisional and subject to change without prior notice.
- Any attempt on part of a candidate to suppress facts, to provide false information or to influence selection directly or indirectly will be treated as a disqualification. If evidence of this surfaces after selection, services may be terminated and admission cancelled, even at that stage. No intimation to non-selected candidates will be sent and no correspondence on this subject will be entertained.
- There is no provision for re-checking/re-evaluation of answer sheets and no query in this regard will be entertained.
- Selected candidates must join course on stipulated date mentioned in letter of selection, failing which selection/admission shall stand cancelled/withdrawn.
- Each selected candidate shall have to pay fee/dues within prescribed period, failing which his/her admission/appointment shall be cancelled.
- Selected candidates shall need to have present original documents (medical registration, date of birth certificate, certificates of educational qualification, experience and relieving and good conduct certificate from University/Institution last attended) for inspection and verification by Institute authorities and submit a self-attested copy of each at time of joining.

- Training programs are full-time and continuous, and private practice in any form after joining Institute is strictly prohibited. Any violation of this may leave to termination of appointment and cancellation of admission.
- Senior Residents admitted to Institute shall maintain good conduct, attend their classes regularly and abide by regulations/guidelines of Institute failing which their names are liable to be struck off rolls of Institute.
- Participation in any agitation, protest, strike, etc. is prohibited. Candidates not abiding with these provisions are liable to be terminated.
- Ragging is strictly prohibited. If any incident of ragging comes to notice of authority, concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, authority would expel him/her from Institute.
- Decisions taken by Director of Institute in all matters related to selection of candidates for admission to various courses shall be final and no appeal shall be entertained on this subject.
- Private practice in any form during course is prohibited. Period of training is strictly full time and continuous.
- These rules are subject to change in accordance with decisions of Institute, taken from time to time.
