III. ELIGIBILITY CRITERIA & DURATION OF THE COURSE

A. General Eligibility criteria for admission to Ph.D. Course:

A Candidate seeking admission to course of study leading to award of a Degree of Doctor of Philosophy must possess at least one of following qualifications of a recognized University/Institute:

1. For Medical Sciences:

- I. MBBS /BDS degree or equivalent with minimum of 55% aggregate marks or Equivalent percentile in Professional examinations
- II. MD/MS/MDS/DM/MCh in Subject concerned or Diplomate of National Board of Examinations or equivalent degree recognized by MCI/DCI.
- III. Master's degree after BAMS, BHMS, BNYS for candidates from AYUSH discipline.
- **2. For Nursing:** Candidates holding M.Sc. degree with minimum 55% aggregate marks or equivalent percentile in Nursing specialty.
- 3. For Non Medical: Master degree (02-year course) awarded by Indian University or equivalent in subject as per requirement of project. Candidates holding MSc (Other than MSc Nursing), M Biotech/ M Tech degree / M Com / MBA/ MPH will be eligible for non-medical qualification category as per AIIMS Rishikesh. Candidates having eligibility under non-medical category should have at least 55% marks or equivalent in last eligibility examination qualified.

*Candidate possessing Master's Degree through distant learning course shall not be eligible.

Relaxation in Qualification for all Candidates.

A relaxation of 5% of marks from 55% or an equivalent relaxation of percentile / grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled and female Candidates.

- B. Eligibility for Own Government fellowship (OF) seats: To be eligible for OF seats, candidates must fulfill following criteria:
 - Candidates who have qualified the National Entrance Tests in any one of following national entrance tests in last 2 years (1 June 2021 to Last date of application) leading to the award of a fellowship viz. SRF/JRF from any Government organization viz. CSIR, DBT, DST, UGC etc. tenable at AIIMS Rishikesh.

C. Eligibility Criteria for External Candidates in permanent employment:

- 1. Implies In-service or sponsored candidates who will receive their salary/stipend from the sponsoring/parent organization, subject to submission of sponsorship certificate from the sponsoring agency.
- Candidates who are permanent employees of external Institutions (Central Govt/ Semi Govt/ Autonomous organization) should submit application through proper channel. i.e. employer. They will be required to submit a 'No Objection Certificate" from their employer at the time of Stage II examination.
- 3. In addition, such Candidates will have to provide a certificate at time of joining from employer stating that in event of selection to PhD course, Candidate will be granted a minimum period of 03-year study leave with full pay and permission to work at AIIMS Rishikesh to pursue full time PhD Course.

D. Eligibility criteria for In-service- Candidates from AIIMS Rishikesh

- Applicants from AIIMS Rishikesh Only those faculty/scientists/administrative officer/officials, whose tenure is of 3 years or more (subject to fulfillment of eligibility criteria), will be allowed to apply as internal candidate. They will be required to submit a 'No Objection Certificate" from their employer at the time of Stage II examination. DM, MCh, PDCC candidates and others pursuing full time academic courses at AIIMS Rishikesh cannot apply for a PhD programme simultaneously.
- 2. If a faculty is registered as a guide of a PhD scholar, he/she will NOT be eligible to apply for PhD Course as a PhD scholar until submission of thesis work by research scholar under him/her.
- 3. Also, any faculty pursuing PhD Course himself/herself is NOT allowed to guide a student.

E. Eligibility criteria for Transfer for PhD credit in case of relocation

 In case of relocation of PhD scholar due to marriage or otherwise, research period, and research data shall be allowed to be transferred to AIIMS Rishikesh, subject to the condition, that Research Scholar has either joined as employee/ on deputation and has cleared entrance exam (Stage I and Stage II) conducted by AIIMS, Rishikesh and is willing to enroll as a full time PhD Research Scholar. Scholar will give due credit to parent guide and previous Institution for part of research already done.

Please Note: Candidates who are likely to complete the requisite qualification and degree by the last date of application may also apply. All such candidates must submit a certificate on the letterhead of the College/Universities, signed and stamped by the Registrar/Dean/Principal confirming that the candidate is likely to complete the eligibility qualification by the last date of application. Candidates who are completing their requisite qualification after the last date of application are NOT eligible to take this examination.

F. Duration of Course

- i. Duration of course for all candidates will commence from date of joining (provisional registration) to submission of final thesis to exam cell for evaluation.
- ii. PhD course will be full time for all external candidates, including those with sponsorship.
- iii. Duration of three years' course will include previous research experience for transferred Scholars and faculty.
- iv. Minimum Duration: Shall be for a minimum period of three years including course work.
- v. Maximum Duration: Shall be for a period of 6 years.

Important Notes:

- 1. All Seats in a department will be clubbed
- 2. Candidates may apply for PhD in one subject and project only.
- 3. Candidates will be eligible ONLY for seats in the department and project that they have applied for.
- 4. Candidates will be allocated seats in order of their merit in the exam.
- 5. Successful candidates will be screened for eligibility criteria of respective Project before admission.
- 6. Candidates who are allotted a seat but do not join or resign after joining will not be eligible for any additional rounds of seat allocation.
- 7. PhD Scholars are required to make their own arrangements for stay at their own expenses during the period of their PhD Course.
- 8. They are also required to identify source of funding support for their research work, as Institute is not bound to support PhD Scholar (External) for their stay/salary/ research funding support.
- 9. The decision of Institutional research Review board (IRRB) will be considered final in all matters pertaining to the PhD course.
- 10. Candidates who are allotted a seat but do not join or resign after joining will NOT be eligible for any additional rounds of seat allocation

IV. <u>Method of selection:</u>

Entrance to PhD Course will be based on merit scores based on following evaluations. All Internal and External candidates (Medical, non-medical, in-house, in-service, transfer-in etc.) will have to appear in two stages of entrance exam:

Stage 1: Written entrance Exam

Stage 2: Departmental assessment and interaction with IRRB

A. Stage I: Written Entrance Exam will comprise of 200 Questions of 3 hours duration of 200 Marks.

If any discrepancy in any question is found in the Entrance Examination, the candidate is advised to write to Dean (Exam), AIIMS, Rishikesh within 24 hours on the following email: <u>exam@aiimsrishikesh.edu.in</u>. This mail will only be used for discrepancy related to question.

Evaluation Procedure for Stage I:

Each correct (MCQ) answer will be awarded 1 mark. More than one answer will be treated as wrong answer. Zero mark will be given for wrong answer, questions not answered or marked for review.

Candidates must score at least 50% marks in Stage I to be eligible for Stage II of entrance exam.

Note:

Candidates with Own government fellowship (OF) as per the criteria mentioned in Section 3, B, point no. 1 above, and in-service candidates of AIIMS Rishikesh will be exempted from the entrance test, i.e. Stage I.

They will appear for Stage II of the Entrance test directly after fulfilling the eligibility criteria for PhD Admission.

Evaluation Procedure for these candidates will be as follows:

For Stage 1: 50% of Marks will be awarded to all candidates with own government fellowship (OF) as per the criteria mentioned in Section 3, B, Point no. 1 and in-service candidates of AIIMS Rishikesh.

If they wish to improve their scores of Stage I, they may appear for Stage I exam.

If they obtain more than 50% in Stage I, these scores will be considered as final and an additional 10 marks will be added to entrance exam-based score of Stage I as special weightage;

If they obtain less than 50% marks in Stage I entrance exam, their final score of Stage I will be considered as 50% marks of Stage I; however additional 10 marks as special weightage will NOT be added to their scores of Stage I.

The final score for all candidates will be computed as follows:

- 80%: Score of Stage I
- 20%: Score of Stage II (Departmental assessment & interaction with IRRB)

Special weightage:

i. Medical / Dental/ Nursing candidates:

10 marks as special weightage extra will be added to total score of Stage I for candidates who fulfil both the following criteria:

- (1) Those candidates who have scored at least 50% in Stage I.
- (2) They hold a Medical Degree (MBBS/ BDS/ MDS/ DNB/ MD/ MS/ DM/ M.Ch.) or M.Sc. (Nursing).

ii. Non-Medical candidate

10 marks will be added to the total score of Stages I for candidates who fulfill both the following criteria:

(1) Those candidates who have scored at least 50% in Stage I

(2) Candidates who have qualified the National Entrance Tests in last 2 years (July 2021

to July 2023) leading to the award of a fellowship viz. SRF/JRF from any Government organization viz. CSIR, DBT, DST, UGC etc. tenable at AIIMS Rishikesh.

NOTE: To be eligible for special weightage marks, ALL the following criteria must be fulfilled:

- 1. The result of the National Entrance Tests listed above must have been declared between 1 June 2021 to Last date of application.
- 2. The award of the fellowship must be based on the result of the above listed National Entrance Tests
- 3. The fellowships should be tenable at AIIMS, Rishikesh
- 4. The letter of award of fellowship must be uploaded with the application form. Passing the listed National Entrance Tests is not acceptable as proof of award of fellowship.

Final Result of qualified candidates will be prepared based on number of seats available. Final result of selected candidates will only be declared after getting approval from Executive Director, AIIMS Rishikesh. Selected candidates are required to join within last date of joining as mentioned in Result information uploaded on Institute website. In case a candidate fails to join by this date and no written request for extension is received, it will be assumed that he/she does not intend to join course and seat will be offered to next candidate on waiting list. No further correspondence will be entertained in this regard. The maximum duration of extension that may be provided to a candidate after approval by Executive Director, AIIMS Rishikesh is one month from the last date of joining.

Note:

- i. Result will be available on website of AIIMS Rishikesh. No individual intimation will be communicated to the Candidate.
- ii. In service candidates of AIIMS Rishikesh, whose candidature is not approved by Institutional Research Review Board will not be eligible for admission.
- iii. Candidates who fail to attend any of the stage of examination as mentioned above will NOT be eligible for admission.

Indemnity Bond:

All Candidates enrolled for PhD Course shall sign a bond for completion of course. Leaving course in mid-way will involve recovery of salary/fellowship and a fine up to Rs 2 lakh based on decision of IRRB. However, Candidate can request Director AIIMS Rishikesh for review of decision of IRRB.

Allocation of Guide:

Candidate shall work under supervision of a recognized Ph.D. guide of AIIMS Rishikesh based on the option chosen by the candidate at the time of application. Candidate for Ph.D. Course shall have option to choose his/her research guide from AIIMS Rishikesh. Allocation of guide will be done by IRRB, from the department in which the candidate has applied for Ph.D. Co-guides will be selected by the guide and scholar based on subject expertise required for PhD thesis. Only a full-time regular teacher/Director of AIIMS Rishikesh can act as a supervisor. External Guides are not allowed. However, Co-Guide can be allowed in inter-disciplinary areas from other departments of AIIMS Rishikesh or from other related Institutions with approval of DRC.

Registration Process: Date of joining shall be treated as date of Registration.

Method of Resolving Tie: The tie cases will be resolved according to age (Date of birth), the older candidate shall get preference over the younger one.

Joining: Selected candidates are required to join <u>as per the date provided in the notification of results</u>. .The Ph.D. Seats shall lapse if the selected candidates do not join by 31.08.2023 for July session. No candidate shall be allowed to join after 31.08.2023 for July session. In case the candidate is not granted an extension for joining and fails to join by the date given to him/her in provisional offer letter, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list. No further correspondence will be entertained in this regard.

V. IMPORTANT INSTRUCTIONS FOR FILLING UP APPLICATION FORM

- For applying for admission to PhD Course each candidate is required to fill the Online google form available on the website (www.aiimsrishikesh.edu.in) i.e.(<u>https://forms.gle/XHvuTbhQCaE1wryk9</u>). He/She is ALSO required to submit hard copy of duly-typed and signed application form provided as a MS word document file on the website to *Dean (Exam), AIIMS, Rishikesh, Veerbhadra Marg, Rishikesh 249203* through registered post/ speed post. The envelope should be superscribed as "APPLICATION FORM FOR PHD ADMISSION JULY 2023."
- 2. It is mandatory to fill up BOTH Google form and also send the typed signed hard copy of Application form to AIIMS Rishikesh as per the instructions provided in the prospectus. In absence of receipt of either of the forms, the application process will NOT be considered complete and the candidature will be cancelled.
- 3. No candidate should register more than one application.
- 4. Candidate should fill in the Google Form taking utmost care. Incorrectly filled form may lead to rejection. It will be the responsibility of the candidates to ensure that correct details are filled in the Google Form. The Institute will not be responsible for any incorrect information/cancellation of candidature/loss or lack of communication etc. due to wrong filled online Application form. Applicants must fill all the fields carefully since after submission of online application request for change in any information at any later stage will not be considered. Candidates should keep a copy of both the forms for future reference till the completion of admission process.
- 5. The fee for entrance examination is non-refundable and no correspondence in this regard will be entertained. The candidate is required to go through the Prospectus carefully and acquaint himself/herself with all requirements with regard to ELIGIBILITY CRITERIA of filling of the application form. Candidates may please note that unless they make the payment of Application Fee, their application will be treated as INCOMPLETE.
