TERMS AND CONDITIONS FOR CONTRACT APPOINTMENT FOR FACULTY POSTS

1. Posts are purely on **CONTRACT BASIS** for tenure not exceeding a period of one year. If contract is not extended further, same will lapse automatically. Appointment can also be terminated at any time, on either side,
2. Appointee shall perform duties as assigned to him/her. Competent authority reserves right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
3. Appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to Government Servants, appointed on regular basis.
4. Appointee shall not be granted any claim or right for regular appointment to any post of AIIMS, Rishikesh.
5. Appointee shall be on whole time appointment of AIIMS Rishikesh and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during period of contract.
6. Appointment to said post will be subject to medical fitness from competent medical board for which he/she will be sent to designated Medical Authority.
7. Leave entitlement of appointee shall be governed in terms of instructions contained in DoPT&T's O.M. No.12016/3/84-Estt.(L) dated 12th April, 1985 as amended by OM No. 12016/1/96-Estt(L) dated 5th July, 1990.
8. On appointment, appointee will be required to take an oath of allegiance to Constitution of India or make a solemn affirmation to that effect in prescribed proforma.
9. Appointee is not entitled to any T.A. for attending interview and joining appointment.
10. Other conditions of service will be governed by relevant rules and orders issued from time to time.
11. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as Government may deem necessary.
