- 1. Lighting of areas as mentioned in Plan attached including all consumables and non-consumables.
- 2. Color of Uplighters and down lighters will be Purple in color.
- 3. Areas to be Decorated with lighting works (Map Attached)

 - Road in front of gate no. 2
 - Road in front of gate no. 3
 - 2 Nos. Fountains
 - Front of Trauma Block, Hospital Block, OPD block and Medical College Block

- 4. Fancy lighting compulsory on all trees near above mentioned locations.

1. Eligibility Criteria

1.1 Main eligibility of service provider will be- Experience of "Arrangement of President of India, Prime Minister of India and Home Minister has been done earlier"

Proof shall be attached with quotation offer.

Similar work will be considered as defined as the work for fixing and arranging Lighting, for high level functions function like Foundation Laying Ceremony / 21Pag

Inauguration Ceremony/ Convocation / Cultural Festival / Sports Function of State Govt. University / Centre Govt. University / Public Sector Unit, Convocation / Cultural Festival / Sports Function of State / Centre Govt. Universities, IITs, IIMs and where in President of India, Prime Minister, Home Minister either chaired or were chief guests, at in any department of Central or State Government/ Public Sector Undertakings/ Autonomous bodies of Govt. of India or State Govt./ National level Educational Institutions/ Professional Bodies in India or abroad.

- 1.2That firm qualified having required experience as mentioned herein above will be called for presentation on 17th of February 2020 at 10:00 AM.
- 1.3 That the firms qualified under presentation will be required to submit their Financial Bid after successful presentation in provided format.
- a. Bids received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
- b. Bids must be in enclosed prescribed Performa on letter head of firm duly signed by Proprietor/ Partner/ Director or their authorized representative, in case of signing of bid by authorized representative letter of authorization must be attached with bid.
- c. Rate must be quoted as per format specified Taxes extra if any must be written separately.
- d. No overwriting or cutting is permitted in rate. If found, the financial bid shall be summarily rejected.
- e. RTGS/NEFT details need to be furnished by supplier with quotation on letter head of supplier/firm/agency.
- f. Firm/agency may satisfy following conditions and attach self-attested copy same with quotation:
- Firm shall be registered with Government of Uttarakhand/Central Govt.
- Firm shall have valid VAT/Sale Tax No. And IT PAN.
- Firm should not be black listed by any Govt. Agency/Dept.

2. Terms and Conditions

- 1. Bidder shall visit site before participating in the bid.
- 2. Bidder must have experience of large functions
- 3. All the preparations must be completed by 11th or 12th March so that any short fall found during inspections may be get rectified.
- 4. Final Trail of all Lighting and decorations work shall be done on 12th March 2020
- 5. Successful bidder shall use new wiring and cables for connections without joint.
- 6. The bidder firm shall possess experience of similar work and attach proof in support.

- 7. The annual turnover of the bidder in each of the last three years should be minimum 3 crores and documentary proof in the form of audited financial statement (Income statement, balance sheet) must be provided as evidence.
- 8. The Tenderer will have to make all necessary changes as may be required by the University/District Authorities in the interest of work and security requirements for holding programmes with VVIP as guests and in attendance.
- 9. Only those tenders shall be accepted which give the offer for entire work i.e on turnkey basis. (tenders for part work will not be accepted)
- 10. Bidders must ensure that the work related to electricity etc must be done only through valid registered and license holders. This has to be ensured through submission of valid Licence/ registration details along with consent of the concerned party(s) along with the submitted tender documents as a requirement.
- 11. The work should be completed within the stipulated time given from the date of order as mentioned in work order.
- 12. The party shall be responsible for security of all its items.
- 13. Quantities are liable to vary.
- 14. The bidder should ensure that the items like LED fixtures, Fancy Lights, wires and cables provided are new and clean.
- 15. Institute shall not be responsible for any kind of loss, Theft and insurance coverage.
- 16.ESI, PAN, GST number and Labour Department's latest registration /Certificate is essential
- 17. Attested copies of same are to be attached.
- 18. Authorized signatory has to keep all the original documents for inspection at the time of opening of tender.
- 19. In case of change of date of the Convocation due to any unforeseen reason, the successful bidder has to make the arrangement for the event for the revised date at the original quoted amount and and shall bear insurance costs associated if any with the event on his own.
- 20. The arrangements shall be ready in all respects for inspection by Engineer In charge / security persons, rehearsal etc one day (24 hours) before the actual main convocation function and shall continue to be provided till 10 pm on the day of the convocation event.
- 21. Bidder must have first class electrical valid license.
- a. **Delivery Period** Assigned services should be started by 10 days before of event and will be completed 1 day before of event from issuing work order.
- b. Liquidated Damage: If supplier fails to deliver requisite services in a desired manner on or before of stipulated date mentioned at (k) above, then a penalty at rate of 0.5% per day of total order value shall be levied subject to maximum of 10% of total order value.
- c. Payment Terms: Payment will be made only after satisfactorily conduction of event and inspection of services made by committee of AIIMS Rishikesh.
- d. Disputes: In event of any dispute or disagreement arising between services by AIIMS

Rishikesh with regards to interpretation of "Terms & Condition" of this inquiry, same shall be referred to Director, AIIMS Rishikesh whose decision will be final and binding upon Supplier.
