 - 1.3 That the firms qualified under presentation will be required to submit their Financial Bid in specified format as provided herein as Annexure
- a. Rate must be quoted as per format specified Taxes extra if any must be written separately.
- b. No overwriting or cutting is permitted in rate. If found, the financial bid shall be summarily rejected.
- c. RTGS/NEFT details need to be furnished by supplier with quotation on letter head of supplier/firm/agency.

 - Firm shall have valid GSTN and IT PAN.

2. Terms and Conditions

- Bidder shall visit site before participating in the bid.
- Bidder must have experience of large functions
- All the preparations must be completed by 11th or 12th March so that any short fall found during inspections may be get rectified.
- Final Trail of all Sound System work shall be done on 12th March 2020
- The bidder firm shall possess experience of similar work and attach proof in support.
- The annual turnover of the bidder in each of the last three years should be minimum 3
 crores and documentary proof in the form of audited financial statement (Income
 statement, balance sheet) must be provided as evidence.
- The Tenderer will have to make all necessary changes as may be required by the University/District Authorities in the interest of work and security requirements for holding programmers with VVIP as guests and in attendance.
- Only those tenders shall be accepted which give the offer for entire work i.e on turnkey basis. (tenders for part work will not be accepted)
- Bidders must ensure that the work related to Sound System etc must be done only through valid registered and license holders. This has to be ensured through submission of valid License/ registration details along with consent of the concerned party(s) along with the submitted tender documents as a requirement.
